Harvey Kronberg has been the editor of *Quorum Report*, the Newsletter of Political Texas, since 1989. *Quorum Report* is a nonpartisan online publication covering state politics and government from an insider's perspective at www.quorumreport.com. Originally a contract writer for *Quorum Report*, Kronberg bought the publication in 1998 and converted it to the first exclusively online subscriber-based publication covering Texas politics and government for political professionals. He also runs *Texas Energy Report* and is a political analyst for Time Warner Cable News and a regular on their nightly *Capitol Tonight*.

Jennifer Cawley is the Executive Director for the Texas Association of Life and Health Insurers, a position she has held since 2008. Prior to joining TALHI, Jennifer was the Senior Associate Commissioner for the Life, Health & Licensing program at TDI, and served as an advisor to Governor Rick Perry. Jennifer has worked in and around the Capitol since 1997.

Mike Meroney of Meroney Public Affairs LLC was recognized and ranked as one the top 100 "Hired Gun" Lobbyists in Texas by the online political magazine *Capitol Inside* in both 2011 and 2013. Prior to that, he was the state and federal lobbyist for Huntsman and a member of Austin-based Public Strategies, Inc.
